A licensed dealer of firearms is required to record the acquisition and disposition of all firearms into an Acquisition and Disposition book. If invoices are retained, the licensee has seven days to record the acquisition of a firearm, otherwise it must be recorded by the close of the next business day. The disposition of a firearm must be recorded within seven days of such disposition. The specific format required for the record of receipt and disposition of firearms (Acquisition and Disposition Record) is to be recorded as one entry across the page, by date of acquisition and includes the Description of the Firearm: Manufacturer and/or Importer, Model, Serial number, Type of Firearm, Caliber or Gauge, the Receipt Date, and the Name and Address or Name and Federal firearms license (FFL) number from whom the firearm was received, the Disposition information shall include the Disposition date, the Name of the person or Federal firearms licensee, and the Address or FFL number, or the Form 4473 serial number if filed numerically.

During a recent inspection of your firearms business, covering the period January 1, 2013 through November 17, 2015, you were cited for violations of Title 27, Code of Federal Regulations, Part 478. A copy of the Report of Violations, ATF F 5030.5, issued at the time of the inspection is enclosed.

All violations were fully explained to you by Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Industry Operations Investigator (b)(6). You indicated that you understood the requirements of the firearms laws and regulations and that corrective action would be taken to eliminate future violations.

The records you are required to maintain and the business operations you conduct are important to law enforcement in our continuing efforts to reduce violent crime and protect the public.
