Dear Mrs. Lock:

During a recent compliance inspection at your firearms business covering the period of December 1, 2016, through March 9, 2017, you were cited for two (2) violations: 27 CFR 478.125(e) REPEAT, and 27 CFR 478.126a REPEAT. These violations were discussed with you during the inspection.

All violations were fully explained to you by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Industry Operations Investigator, (b)(6). You indicated that you understood the requirements of the firearms laws and regulations. You were advised to review you ATF Forms 4473s more vigilantly to ensure that you report all multiple sales of handguns on ATF F 3310.11 as required. You were also advised to account for your firearms inventory more efficiently as firearms were reported missing as a result of the compliance inspection. You further indicated that corrective actions would be taken to eliminate future violations relative to these issues.

The records you are required to maintain and the business operations you conduct are important to law enforcement in our continuing effort to reduce violent crime and protect the public. It is imperative that you account for your firearms inventory efficiently and that you report all multiple sales of handguns on ATF F 3310.11 as required as both of these business practices have a direct impact on public safety and should be taken very seriously. <a href="Furthermore both of the violations cited were repetitive from the past inspections and you attended Warning Conferences and received Warning Letters in 2012, 2007, 2003, and 2000 for similar repetitive violations."

It is essential that you comply with all Federal laws and regulations that govern your firearms business. This is critical to carrying out our mission to protect the public and ensure that criminals do not gain access to firearms.

ATF appreciates the efforts you and other industry members make in this area, and we look forward to continuing to work with you in that regard.

You are reminded that retention of your Federal firearms license is conditioned upon your compliance with Federal laws and regulations. Any future violations, either repeat or otherwise, could be viewed as willful and may result in the revocation of your license. Please ensure that future compliance is achieved.
