During a recent inspection at your firearms business covering the period March 2015 to March 2016 you were cited for violations of Title 27, Code of Federal Regulations, Part 478. A copy of the Report of Violations, ATF F 5030.5, issued at the time of the inspection is enclosed.

All violations were fully explained to you by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Industry Operations Investigator (b)(6).

You indicated that you understood the requirements of the firearms laws and regulations and that corrective actions would be taken to eliminate future violations. This Warning Letter is sent to emphasize your responsibility as an FFL and to advise you to contact us in the future with any questions or concerns.
