Explosives (ATF) initiated an unannounced Disposition Emphasis compliance inspection for Federal Firearms Licensee, Shooter's Roost LLC. Member Eric Stratton, was interviewed at the business premises in Beckley, WV. The inspection period was from February 9, 2015 through February 9, 2016. The on-site inspection concluded February 18, 2016.

Member Eric Stratton stated that he intends to renew the ATF license prior to the expiration date of August 1, 2016.

This inspection involved an inventory of 622 firearms and an examination of 1,500 Forms 4473. Five (5) violations were cited - 27 CFR 478.22(a); 27 CFR 478.125(e); 27 CFR 478.21(a); 27 CFR 478.124(c)(1); and 27 CFR 478.126a.


