 WL, ROV and recall: A compliance inspection was initiated on 10/21/2015, and closing completed on 11/04/2015 in Bay Minette, AL. The inspection disclosed 3 violations : 27 CFR 478.21(a) - **(b)(6)** instances failed to complete correctly Section A, question **(b)(6)** (incorrect or blank answers); 27 CFR 478.124(c)(1) - **(b)(6)** instances failed to complete correctly Section A, question **(b)(6)** and questions **(b)(6)** - I (incorrect or blank); 27 CFR 478.126a - **(b)(6)** instance (involving **(b)(6)** handguns) failed to complete the multiple handgun sale report. A ROV was issued. Additional reviews have been implemented to ensure the violations are not repeated in the future. A corrected ROV was issued to further clarify the # of Forms with errors/question # on the forms. The licensee signed and returned the updated ROV (both the original and correct ROVs are in N-Spect). A WL was mailed to the FFL on 11/24/15. No further field action is required.


