Alternate Recommendation: From Warning Conference to Viols WL ONLY and Recall Inspection

In August 2016, a compliance inspection of the licensee, Mike Strong, Inc. dba A Pawn Shop, was conducted. The inspection resulted in the identification of several violations of 27 CFR 478.125(e). Specifically, IOIs identified acquisition related violations which was 12.3% of the licensee's total acquisitions for the inspection period. According to ATF O 5370.1B, Section 6.d.1, the identification of acquisition related violations in (b)(7)(E) of the licensee's total acquisitions merits a warning conference.

Justification for Alternate Recommendation:

When the licensee began business in June 2010, it was unaware of how to enter firearms that were related to Internet transfers into its computer database, Pawn Master. Due to this, the licensee kept handwritten records as its official ATF acquisition and disposition records but also utilized Pawn Master as unofficial records to keep track of all firearms acquired and/or disposed of by the licensee that were related to pawns and/or inventory sales. During the course of business, the licensee explained that it became complacent ir maintaining its handwritten records because its computer system contained the most current information regarding a majority of its firearms acquisitions and dispositions. Because of this, the licensee failed to log in firearms into its handwritten (official) A&D record. These omissions accounted for 12.3% of the licensee's total acquisitions for the inspection period.

IOI (b)(6) reviewed the licensee's unofficial computerized records which contained the information required in 27 CFR 478.125(e). Additionally, all firearms noted above were logged into the computerized records system. During the inspection, the licensee learned how to enter firearms related to Internet transfers into Pawn Master and advised IOI (b)(6) that it planned to convert its record keeping to a computerized record keeping system. IOI provided the licensee with a copy of ATF Ruling 2016-1 and advised the licensee of its retention requirements for its handwritten records.

Since the licensee's unofficial records contained the information required by regulation and because the licensee intends to utilize Pawn Master as its official records, it is recommended that a warning letter be mailed to the licensee and a recall inspection be conducted.
