Dear Mr. Green:

During a recent inspection at your firearms business covering the period July 15, 2014 to July 15, 2015, you were cited for a violation of Title 27, Code of Federal Regulations, Part 478. A copy of the Report of Violations, ATF F 5030.5, issued at the time of the inspection is enclosed. This violation was fully explained to you by a Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Industry Operations Investigator (IOI).

Of particular concern is the firearms inventory that you were unable to account for and were required to report missing. When firearms are reported missing, the ability to trace these firearms is eliminated. I urge you to continue searching for these firearms or any information as to the disposition of these firearms. Should you locate the firearms or disposition information for the firearms, please report the information to the ATF National Tracing Center (1-800-930-9275).

The IOI also recommended that you conduct full inventory reconciliations on a regular basis and to institute policies to ensure that firearm entries are made in the A&D record in a timely manner. I have enclosed a copy of the ATF Publication: "Federal Firearms Licensee Quick Reference and Best Practices Guide." I suggest that you review the entire publication and that you give particular attention to the section titled "Accountability for Firearms" on pages 9 and 10. Implementing policies based on the best practices recommended in this section of the publication will better enable you to account for your business assets, identify security issues, and provide quick reporting of firearms that have been lost or stolen from your business.

The records you are required to maintain and the business operations you conduct are important to law enforcement in our continuing efforts to reduce violent crime and protect the public. It is



essential that you comply with all Federal laws and regulations that govern your firearms business. This is critical to carrying out our mission to protect the public and to ensure that criminals do not gain access to firearms. ATF appreciates the efforts you and other industry members make in this area. We look forward to continuing to work with you in that regard.

You are reminded that retention of your Federal firearms license is conditioned upon your compliance with Federal laws and regulations. Any future violations, either repeat or otherwise, could be viewed as willful and may result in the revocation of your license. Please ensure that future compliance is achieved.
