Dear Mr. Hansen:

During a recent compliance inspection at your firearms business on September 9, 2016 you were cited for violations of 27 Code of Federal Regulations, Part 478. Refer to the copy of the Report of Violations, Form 5030.5, issued at the time of the inspection.

The violation was fully explained to you by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Investigator (b) (6). You stated that you understood the requirements of the firearms laws and regulations. You further indicated that corrective actions would be taken to eliminate future violations. Those actions associated with the corresponding violation are as follow:

**27 CFR 478.126a**

**Nature of violation:**

(b)(3)- Public Law 112-55 (125 Stat. 552)  
Failure to report the multiple handgun sales on (b)(6) occasions when licensee transferred handguns to unlicensed individuals.

**Corrective action:**

(b)(6)  
Investigator (b)(6) instructed you to submit the report of multiple sales and try to verify all future transactions are handled properly.

The records you are required to maintain and the business operations you conduct are important to law enforcement in our continuing effort to reduce violent crime and protect the public. It is essential that you comply with all Federal laws and regulations that govern your firearms business. This is critical to carrying out our mission to protect the public and ensure that criminals do not gain access to firearms. ATF appreciates the efforts you and other industry members make in this area, and we look forward to continuing to work with you in that regard.

You are reminded that retention of your Federal firearms license is conditioned upon your compliance with Federal laws and regulations. Any future violations, either repeat or otherwise, could be viewed as willful and may result in the revocation of your license.
