Dear Mr. Luck,

During a recent compliance inspection at your firearms business on April 18, 2017, you were cited for violations of 27 Code of Federal Regulations, Parts 478 and 479. Refer to the copy of the Report of Violations, Form 5030.5, issued at the time of the inspection.

The violation was fully explained to you by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) Industry Operations Investigator (b)(6). You stated that you understood the requirements of the firearms laws and regulations. You further indicated that corrective actions would be taken to eliminate future violations. Those actions associated with the corresponding violation are as follow:

27 CFR 478.41(a)

Nature of violation:

Failure to obtain a Type 07, Manufacturer of Firearms Other Than Destructive Devices license prior to engaging in the business of manufacturing, including assembly of firearms for sale, in instances.

Licensee's response:

The licensee stated that he thought that if a customer requested that a firearm be built that it was not manufacturing. He stated he now understands the definition and will be obtaining the correct Type 07 license before manufacturing any other firearms.

27 CFR 478.125(e)

Nature of violation:

Failure to maintain an accurate Acquisition & Disposition (A&D) Record in instances:

- instances of failing to enter a firearm into the A&D Record.
- instances of failing to record the disposition of a firearm into the A&D Record.
- firearms were found to be missing.

Licensee's response:

The licensee stated that most of the errors were due to problems with the first computerized record system and then the subsequent switch to a new system. In addition, he stated that he has gotten busy and forgotten to log firearms.

Failure to ensure proper completion of the ATF Form 4473 per the form instructions in instances.

Licensee's response:

The licensee stated that he did not know that he had to complete those particular blocks of the form. He stated that he now realizes the importance of completing the form properly and will do so in the future.

Failure to ensure that the transferee properly completed Section A of the ATF Form 4473 in instances.

Licensee's response:

The licensee stated that these errors were oversights.

Licensee's response:

The licensee stated that these errors were oversights.

Nature of violation:

Failure to sign and date the ATF Form 4473 in instances.

The licensee stated that he did not realized these blocks had to be completed.

27 CFR 478.126a

Nature of violation:

The licensee failed to file ATF Form 3310.4, Report of Multiple Sale or Other Disposition of Pistols and Revolvers, in instance.

Licensee's response:

The licensee stated that this was an oversight.

The records you are required to maintain and the business operations you conduct are important to law enforcement in our continuing effort to reduce violent crime and protect the public. It is essential that you comply with all Federal laws and regulations that govern your firearms business. This is critical to carrying out our mission to protect the public and ensure that criminals do not gain access to firearms. ATF appreciates the efforts you and other industry members make in this area, and we look forward to continuing to work with you in that regard.

You are reminded that retention of your Federal firearms license is conditioned upon your compliance with Federal laws and regulations. Any future violations, either repeat or otherwise, could be viewed as willful and may result in the revocation of your license.
